CREDIT TERMS

- Upon approval of credit, Raritan Group* will extend credit terms to applicant for merchandise it receives. Credit terms are net thirty (30) days from date of invoice(s) and are due and payable in full thereon. Payments received after the 30th day of invoice date may be subject to a 1.5% per month interest charge. Should credit availability be granted by Raritan Group*, any decision with respect to the extension or continuation shall be at the sole discretion of Raritan, and it reserves the right to terminate that availability at any time.
- In case of returned merchandise, the applicant must request and obtain prior written authorization from Raritan Group's* Customer Service Department to receive a credit on its account. All invoices are to be paid in full. All credits will be applied to the net account.
- Default in the payments of any invoice(s) shall, at the option of Raritan Group* and without notice or demand, render the entire balance at once due and payable in full.
- If the invoices due under the terms of this credit agreement are not paid by the due date and it is necessary for Raritan Group* to take steps to collect on the debt, the applicant agrees to pay all reasonable collection costs, including attorneys' fees, which are incurred by Raritan Group* to collect the debt.
- This agreement shall be governed by and construed in accordance with the laws of the State of New Jersey without regard to its conflicts of law principles
- All obligations of the parties created hereunder are performable within Middlesex County, New Jersey.
- Applicant consents to and agrees that exclusive proper jurisdiction over any dispute between the undersigned and Raritan Group* arising from this agreement or any other aspect of the relationship between Applicant and Raritan shall be in the state or federal courts located in the State of New Jersey.
- Applicant Agrees to accept as valid service of process service made by courier delivery.
- Applicant authorizes its bank and suppliers to furnish Raritan Group* with all information to complete Raritan Group's* evaluation of the applicant's creditworthiness. Raritan Group* is hereby authorized to investigate the credit references and principals listed.
- By signing below, Applicant acknowledges and agrees to all terms and conditions set forth above.
- A "Credit hold" imposed by Raritan Group* at any time during the year negates any special terms.
- Any misrepresentation or omission in this application will be considered evidence of fraud since this information is being relied upon by Raritan Group* in deciding whether to extend credit to the Applicant. As an inducement to grant an extension of credit, the undersigned warrants and represents, individually and as a representative of the Applicant, to Raritan Group* that the information submitted is true and correct.
- In consideration for the extension of credit, the Applicant and the principals jointly and severally promise to pay for all purchases in compliance with the agreed upon terms of sale.
